The Memorandum of Understanding (MOU) as outlined in this document is not intended to be a legally binding document. Rather, it is meant to describe the nature and cooperative intentions of those institutions involved and to suggest guidelines for cooperation. Nothing, therefore, shall diminish the full autonomy of either institution, nor may any constraints be imposed by either upon the other, and nothing in this Agreement shall be deemed to create a partnership, joint venture, or agency relationship between the parties.

The Memorandum of Understanding shall remain in force for a period of five (5) years from the date of the last signature and will be renewed automatically for periods of the same duration unless it is revoked with the understanding that it may be terminated by the appropriate authorities of either party giving two (2) months notice to the other party in writing, unless an earlier termination date is mutually agreed upon. The MOU may be amended or extended by mutual written consent of the two parties.



Idar Anjana Patidar HKM Arts and PN Patel Commerce College, Idar and S.D. Arts & Shah B.R. Commerce College, Mansa, wishing to establish relations between the two institutions, hereby agree to cooperate with each other in areas of mutual interest as follows:

1. The purpose of this Agreement is to develop academic and educational cooperation and to promote mutual understanding between the institutions.
2. Both institutions agree and shall endeavor to promote collaborative activities in academic areas of mutual interest on a basis of equality and reciprocity, which shall include but not be limited to the following:
 - a) Exchange of academic information and materials
 - b) Promoting other academic cooperation as mutually agreed
 - c) Exchange of faculty, researchers and other research administrative staff
 - d) Exchange of students: graduate and undergraduate to be specified in separate negotiated agreements
 - e) Conducting collaborative projects and research collaboration
 - f) Conducting lectures and organizing symposia
3. Financial and/or funding considerations shall become the subject of specific discussion and agreement within the framework of a separate implementation agreement. No financial commitment whatsoever, on the part of either signatory to this general document, is intended or implied.
4. It is understood that the implementation of any of the types of cooperation stated in clause 2 shall depend upon the availability of resources and financial support at the institutions concerned.
5. Should any collaborative research activity under this Agreement result in any potential for intellectual property, both institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise.
6. Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed upon. The designated liaison officers for this Memorandum of Understanding are:
